### 2023 HAPA (OAHU CHAPTER) SCHOLARSHIP FOR UNDERGRADUATE OR GRADUATE STUDENTS

#### Purpose

This scholarship was established by the Oahu Chapter of the Hawaii Association of Public Accountants (HAPA) to encourage students to pursue careers in the field of public accounting. HAPA is a professional organization of accountants in public practice providing accounting and financial statement services for individuals and small businesses. HAPA is the Hawaii chapter of the National Society of Accountants.

#### Award

A \$2,000 scholarship is available for students in undergraduate or graduate programs on Oahu. The recipient will be notified on or about October 25, 2023.

#### Eligibility

The applicant must:

- be currently enrolled;
- be a resident of the State of Hawaii;
- have a grade point average of at least 3.0;
- have completed a requisite number of accounting classes (4 for undergraduates, and 3 for graduates); and
- not be a previous awardee for this scholarship.

Part-time students will be considered if they provide a written statement on the circumstances preventing them from being full-time students.

#### Application

The applicant should submit:

- a completed scholarship application form;
- a transcript of college record;
- a resume; and
- a one-page essay on the following topic: *a lesson learned during the Covid pandemic that you feel will be useful in your future public accounting career.*

Applications will be evaluated based on the following weighted criteria:

Overall presentation and essay – 40%  
Academic achievement – 25%  
Extracurricular activity- 20%  
Financial need - 15%

HAPA, at its discretion, may request additional details and/or documentation supporting applicants' submissions as considered necessary during its review process.
